

# Guidelines for the Applicants of Ritsumeikan University Incentive Scholarship B for Global COE Program 2009

"Global COE Program Incentive scholarship" is an incentive scholarship to encourage the doctoral program students who do the research at the 3 basis of GCOE Program at the graduate school of Ritsumeikan University. Applicants may apply according to the guidelines below.

## 1. Type of scholarship/amount of money and capacity

\*Type of scholarship: Ritsumeikan University Incentive Scholarship B for Global COE Program

\*Amount of money: 250,000 JPY/per student (benefits-plan)

\*Numbers of recruitment: Annually 9 students per base.

1<sup>st</sup> year student of the doctoral program • • • 3 students/year

2<sup>nd</sup> year student of the doctoral program • • • 3 students/year

Over 3<sup>rd</sup> year student of the doctoral program • • • 3 students/year

【 For the student of a five-year doctoral degree program 】

3<sup>rd</sup> year student of the five-year doctoral degree program • • • 3 students/year

4<sup>th</sup> year student of the five-year doctoral degree program • • • 3 students/year

Over 5<sup>th</sup> year student of the five-year doctoral degree program • • • 3 students/year

## 2. Qualification

\*Applicant should fulfill all the conditions below;

(1) Entered the doctoral program at the Graduate School of Ritsumeikan University in 2009

(2) Doing the research related to the research theme which is propelled by the basis.

【 For the student of a five-year doctoral degree program 】

\* The five-year doctoral degree program student should fulfill conditions below.

(1) In the doctoral degree level in 2009

(2) Doing the research related to the research theme which is propelled by the basis.

## 5. Method of Screening

Based on the recommendation of the leader for each basis, we will have paper screening at the Ritsumeikan University Incentive Scholarship for Global COE screening committee.

## 6. Announcement for the result of screening

We will announce the result for both successful and unsuccessful applicant by postal mail.

## 7. Method of Payment

For the adopter of this scholarship, the scholarship payment will go to your bank account directly in a lump sum after all of the designated procedure had taken.

## 8. Cancellation of the scholarship

When the adopter fall into any conditions below, we may cancel the decision of scholarship payment; the regulation 8

- (1)When the adopter lost one's school register in the year of scholarship receiving.
- (2)When the adopter took a temporally leave from school in the year of scholarship receiving.
- (3)When the adopter has been the subject for punishment based on the reward and punishment rules for the student of Ritsumeikan University.
- (4)When any condition occur which is inappropriate for the recipient of a scholarship while the one in a school.

## 9. Others

- (1)Handing of personal information

\*Usage of all submitted documents are only limited for the screening. In addition, we won't return any of the submitted documents.

\*All of the personal information provided in the submitted documents will only be used for the screening.

- (2)This scholarship will not interfere the receiving of any other scholarship or research fund.

- (3)You will not be able to apply for this scholarship when the multiple benefits are prohibited by the regulation of other scholarship or research fund you've already received.
